

The Health of Benzie and Leelanau Residents

Health Indicators provide a picture of the health status of individuals living in Benzie and Leelanau counties as compared with people living throughout the rest of Michigan. Data presented was obtained from the Michigan Department of Community Health.

Overall, health risks among residents of Benzie and Leelanau are similar to those throughout the State of Michigan and are slightly lower than the national averages.





The district is growing, and its citizens are on the average, getting older.

The rates are adjusted for age differences so that we are comparing "apples to apples". The causes entered only as asterisks include too few deaths for the numbers to be meaningful. In general the rates in our district are lower than is true for the whole state, indicating better levels of overall health and/or the healthcare system here.



COALITION HEALTH ACCESS PROGRAM(CHAP) LAUNCHED IN APRIL 2005

The Coalition Health Access Program (CHAP) was developed by the Grand Traverse Regional Health Care Coalition. CHAP is comprised of a network of health providers and volunteers in Benzie, Grand Traverse, and Leelanau counties. These individuals and organizations donate many health services to uninsured people so they may obtain basic health care. It is not an insurance program, but has been created with donations and other funds targeted for people who meet eligibility requirements.

CHAP members are issued a card that allows access to a regular doctor, nurse practitioner, or physician assistant; basic drugs (mainly generic) at pharmacies, with a small co-pay; labs, basic x-rays and EKG's at Munson Healthcare facilities; and referrals to specialists when ordered by the primary care doctor, nurse practitioner or physician assistant and scheduled by CHAP. To qualify for CHAP, individuals must live in Benzie, Leelanau, or Grand Traverse County; be 19 years of age or older; not have other medical coverage or insurance; and meet income eligibility requirements.

Enrollment applications are completed by appointment at the local health department.


