COVID Testing

The health department is offering free COVID-19 testing with the support of HONU lab. The test is free, and no doctor's order is required. Pre-registration is not required, but it is recommended to reduce time spent at the testing clinic, and walk-ins are welcome. Testing is available:

COVID Vaccine

Vaccination is our most powerful tool. Everyone is welcome at all health department clinics, including residents and non-residents. All three COVID-19 vaccines are available at every clinic. Minors must be accompanied by a parent/legal guardian. Public health nurses are on-site at these events and able to answer any questions about the vaccines. COVID-19 Case Counts

The Benzie-Leelanau District Health Department is reporting the following case information:

- On Friday, September 3, 2 new cases of COVID-19 were reported in Benzie, and 6 in Leelanau.
- On Saturday, September 4, 3 new cases of COVID-19 were reported in Benzie, and 2 in Leelanau.
- On Sunday, September 5, no new cases were reported in either county.
- On Monday, September 6, 0 new cases of COVID-19 were reported in Benzie, and 1 in Leelanau.
- Today, September 7, 4 new cases of COVID-19 were reported in Benzie and 5 in Leelanau.

As of 4:00 p.m. today, the Benzie-Leelanau District Health Department is reporting:

- Total COVID-19 cases in the following counties: Benzie– 1,334, Leelanau– 1,387
- Active COVID-19 cases in the following counties: Benzie– 51, Leelanau– 90
- Recovered COVID-19 cases in the following counties: Benzie– 1,249, Leelanau– 1,279
- Confirmed COVID-19 deaths in the following counties: Benzie – 34, Leelanau– 18
- Hospitalized: 178 total; 1 currently
